PAYROLL TAX RELIEF ALERT

You may have heard that President Trump issued a memorandum to defer Social Security payroll taxes for the remainder of this year. This may provide a nice but temporary boost in your paycheck. However, please be aware and prepared to pay those deferred taxes next year. The taxes that are deferred will be withheld and paid between January 1, 2021 and April 30, 2021. You may or may not be able to choose whether these taxes are deferred. Check with your employer to determine whether they will be deferring taxes.

To make sure that you aren't short on cash at the beginning of the new year when the deferral will be withheld, **SAVE NOW**. Your credit union can help with a club account. Call or come see us to get started!
